### HOLIDAY PROGRAM CONDITIONS AND CODE OF BEHAVIOUR

- ❖ Programs are fully supervised by Australian International Student Tours staff.
- ❖ Parent/Guardian and Student Authorisation form must be completed and returned via email to [admin@australianinternationalstudenttours.com.au](mailto:admin@australianinternationalstudenttours.com.au) by 3<sup>rd</sup> November 2020.
- ❖ Payment must be finalised within 2 days of AIST receiving a completed registration form, and a place in the holiday program being confirmed by email.
- ❖ The Cancellation policy is as follows: The full tour cost less any bank fees will be refunded if the tour is cancelled due to not reaching minimum participant number of 16 students.
- ❖ All pre-departure information will be sent to students at their nominated email address 2 days prior to the departure date.
- ❖ Students may not leave the accommodation area without permission from the tour escort.
- ❖ Smoking, drinking of alcohol or the taking of non-prescribed drugs is strictly forbidden at all times.
- ❖ Students are expected to comply with instructions given by the tour escort at all times.
- ❖ In accommodation boys and girls are to stay in their respective sleeping areas.
- ❖ Students are responsible for their own luggage and personal belongings.
- ❖ It is recommended that students do not bring large amounts of cash or valuables with them.
- ❖ Students must carry a copy of the program itinerary at all times and ensure they have a copy of the current accommodation address and phone numbers.
- ❖ If a student becomes lost they should telephone the tour escort immediately, if this is unsuccessful, they should proceed by taxi to the accommodation as detailed in the itinerary and notify staff of their return.
- ❖ In public places students are to behave in an orderly manner and follow all instructions given by the tour escort.
- ❖ ***A breach of this Code of Behaviour may result in the student's participating in the holiday program being cancelled and the student being sent back to their homestay family/school on the first available transport. Parents (both homestay and natural) and the student's host school will be notified and any additional costs incurred will be the responsibility of the student / parent / guardian.***
